2022 Shareholder Agreement

Community Supported Agriculture consists of a community of individuals who pledge support to a farm operation and share in the risks and benefits of farming, including a poor harvest due to unfavorable weather conditions or pests. Shareholders of the farm pledge in advance to cover the anticipated costs of the farm operation. In return, they receive shares in the farm's bounty throughout the growing season, as well as the satisfaction gained from reconnecting with the land.
